13th Edition of the Mediterranean Short Film Festival of Tangier
05-10 October 2015
FESTIVAL RULES

ARTICLE 1:

The Mediterranean Short Film Festival of Tangier is a manifestation of artistic, cultural and promotional character that aims to:

- Create a framework for meetings, dialogue and film exchanges;
- Promote awareness and dissemination of new short films from Mediterranean countries;
- Encourage young filmmakers realize their creative and artistic ambitions;
- Encourage and promote exchanges between filmmakers from both shores of the Mediterranean.

ARTICLE 2:

The 13th edition of the Mediterranean Short Film Festival of Tangier will take place from **October, 05th to 10th, 2015**

ARTICLE 3:

The festival program includes:

- "Competition section " open to short films made by Mediterranean filmmakers in 2014 and 2015;
- A cinema course;
- Discussions about the films in competition;
- Parallel activities.

ARTICLE 4:

One to five short films by country, Will be selected for the official competition.

The filmmakers selected for the competition will be invited by the film festival with support for transport costs and accommodation half board.

ARTICLE 5:

Participating films must be fiction movies in original version with subtitles in Arabic, French or English and professional format (DCP, HD, BETA SP or DigiBeta). The duration of the movie must be more than **5 minutes and less than 35 minutes**.

Only foreign films that have not previously participated in festivals in Morocco Can participate in the competition.

ARTICLE 6:

All requests to participate must be sent to the secretariat of the festival, by **July 10, 2015** accompanied by a file containing:

- A completed and signed registration form;
- Synopsis of the film in Arabic, French and English;
- Biography and picture of the director;
- Pictures from the film;
- All useful information
- A copy of the movie recorded on DVD or Blu-ray.

ARTICLE 7:

Any producer who submitted a film to the selection will be notified by mail of the decision of the selection committee.

Copies of selected films must be submitted to the secretariat of the festival, along with complete documentation (press, photographs, and posters) no later than **September 1, 2013**.

Any film recorded and retained for the competition can be removed from the selection.

ARTICLE 8:

The cost of sending copies of films participating in DCP, HD, BETA SP or DigiBeta and the return shipment costs are the responsibility of the festival, as well as insurance costs between receiving and forwarding copies.

In case of loss, the liability of the festival is confined within the limits of the value of the support.

In case of damage, the producer must send a certified laboratory invoice within a period not exceeding one month after he took possession of a copy film.

ARTICLE 9:

A jury composed of seven members appointed by the organizers attribute to films competing prizes provided for in Article 10 of this regulation.

ARTICLE 10:

The awards are:

The grand prize of festival	70.000,00 DHS
The Special Jury Prize	60.000,00 DHS
The prize of direction	50.000,00 DHS
Best Screenplay	40.000,00 DHS
The prize of the first female role	20.000,00 DHS
The prize of the first male role	20.000,00 DHS

The jury does not award prize ex-aequo.

A panel of young, award "the prize of the youth." This prize does not have financial reward.

ARTICLE 11:

Any case not provided for in this Regulation remains the responsibility of the organizers.

ARTICLE 12:

Participation in the 13th edition of the of Mediterranean Short Festival Film of Tangier implies unreserved adhesion to present rules.
